The Warwick BCI Balanced Fund of Funds aims to provide the investor with a moderate level of income and long term capital growth.

INVESTMENT UNIVERSE

The portfolio's equity exposure on a look through basis will range between 0% and 75% of the portfolio's net asset value. The underlying portfolios will invest in, amongst others, equity securities, property securities, non-equity securities, interest bearing securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

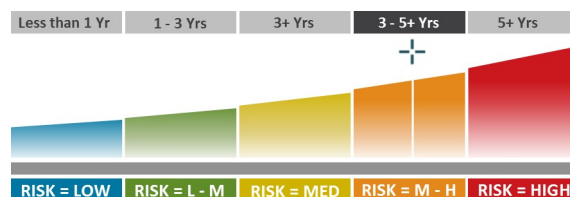

Medium - High Risk
