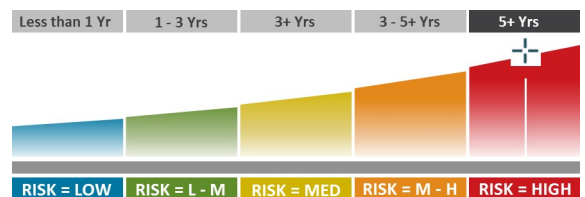

High Risk
