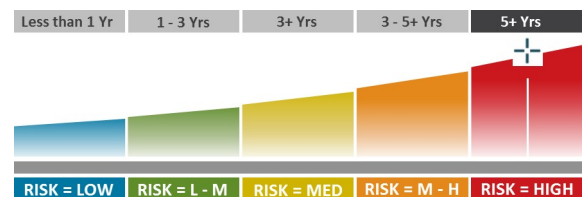

High Risk
