

INVESTMENT OBJECTIVE

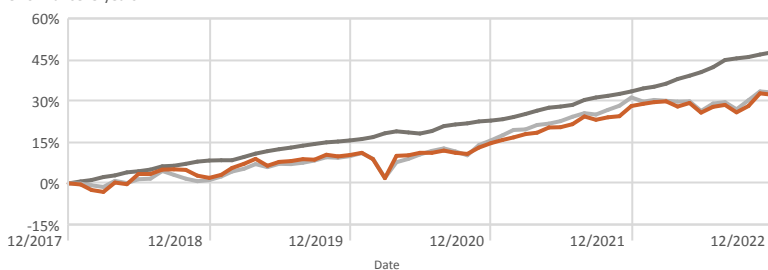
The objective is to provide investors with stable real medium to long term returns, whilst minimising the risk of capital loss over 1 year rolling periods.

INVESTMENT POLICY

The Palmyra BCI Stable Fund aims to provide investors with stable real medium to long term returns, whilst minimizing the risk of capital loss over 1 year rolling periods. The portfolio's equity exposure may not exceed 40% of the portfolio's net asset value. The portfolio has money market instruments, interest bearing securities, bonds, debentures, corporate debt, equity securities, property securities, preference shares, convertible equities and non-equity securities. The manager may invest in participatory interests. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective. The manager shall reserve the right to close the portfolio to new investors on a date determined by the manager. The manager may open a closed portfolio to new investors on a date determined by the manager.

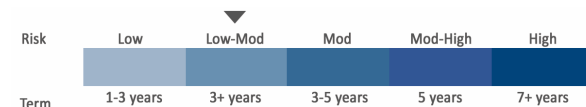
